fers annuity calculator and retirement benefits Jul 23 2022 mra 10 retirement fers employees are eligible for a retirement annuity at the minimum retirement age mra with just 10 years of service however if you retire at the minimum retirement age mra with 10 service but less than 30 years of service your benefit will be reduced by the age reduction

voluntary early retirement authority u s office of personnel management Jun 29 2020 there is no annuity reduction in fers for employees who retire on an early voluntary retirement under age 55 a fers transferee with a csrs component in his her annuity who retires before age 55 will have the csrs portion of the payable annuity reduced by one sixth of one percent for each full month he she is under age 55
